



## What activities make a person eligible for an enhanced criminal record check?

An individual will be eligible for an enhanced criminal record check, if he/ she engages in work which is included in the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 (as amended) and is 'work with children' and / or 'work with adults' as defined in the Police Act 1997 (Criminal Records) Regulations 2002 (as amended). Such work includes the following:

Personal care includes assistance with toileting, washing, bathing and dressing for reasons of age, illness or disability (and prompting and supervision of the same) or teaching a child for reasons of age, illness or disability to do any of these tasks. Assistance with eating, drinking for reasons of illness or disability (and prompting and supervision of the same) or teaching a child for reasons of illness or disability to do these tasks.

6. Child-minding or fostering a child.

- 7. Day to day management on a regular basis of a person who is providing a regulated activity in relation to children. *Please* note this includes a supervisor of a person who would be in regulated activity if not under regular supervision.
- 8. Assessing the suitability of any person who is aged 16 or over to have regular contact with children and who lives in the same household as an individual who is engaged in regulated activity, where the activity normally takes place on the premises where the relevant individuals live.<sup>2</sup>

- Conveying: conveying adults for reasons of age, illness or disability to, from or between places where they receive healthcare, personal care or social work. This would not include friends or family or taxi drivers.
- 7. A person whose role includes the day to day management or supervision of any person who is engaging in regulated activity.

- d. Moderating a **public electronic interactive communication service**,
- e. Any form of work carried on in a care home, ;
- f. Advocacy services ;
- g. Transportation of an adult who receives a health or social care service etc., (whether or not the adult is accompanied by a carer) (except where already included in Column A Adults No. 6 "Conveying").
- 2. Individuals who are trustees of a vulnerable adult's charity.
