

## Introductory note for the Diocesan Synod, 18 November 2023

## To: Diocesan Synod members

Please find enclosed the agenda and papers for Diocesan Synod on 18 November at Pattern Church, Penzance Drive, Swindon, SN5 7JL. It is **vital** that those attending stay for the whole duration of Synod, especially the more formal parts which require a quorum. We have come close to falling below this level at previous Synods.

This meeting is largely formed of three parts.

The **first** part will cover routine business and will include reports from the most recent meetings of Bishop's Council / Board of Directors / DMPC and an update from Transforming Church. Together (TC.T). It will also include a proposal to amend Standing Orders (the rules that govern Diocesan Synod and Bishop's Council (Standing Committee)).

The **second** part will showcase how parishes from across the diocese have taken up TC.T and introduced new initiatives, as well as introducing the Diocese's newest BMO, The Well. It will also look at the financial plans for the year ahead in order that the Synod might approve the Bristol DBF's expenditure for 2024. Time has been built into the agenda for round table discussions and questions, so please do give time to thinking about any questions you might wish to raise at Synod.

The **final** part will focus on General Synod and the ongoing discussions about Living in Love and Faith (LLF). Time has been put aside so that Synod members have opportunity to discuss General Synod' response to LLF and ask questions.
